PTO By-law amendment vote on the below changes:

Article IV – Officers and Elections

Section 3. Nominations and Elections. Elections will be held at the second to last meeting of the school year. The nominating committee shall select a candidate for each office and present the slate at a meeting held one month prior to the election. At that meeting, nominations may also be made from the floor. Voting shall be by voice vote if a slate is presented. If more than one person is running for an office, a ballot vote shall be taken.

Replace with:

Elections will be held one week prior to the last meeting of the school year via online ballot. The nominating committee will send out an email to members one month before the last meeting inviting members to self nominate for the office of President, Vice-President, Secretary and Treasurer. The nominating committee will send out a ballot vote (online) one week prior to the last general meeting. PTO Membership will vote by online ballot. Voting opportunities go for a week and close the night (midnight) before the general meeting. The results will be announced at the general membership meeting. The newly elected officers will begin their term at the last executive board meeting of the school year.

Article V - Meetings,

Section 3. Meetings. Regular meetings shall be held monthly,

Special meetings may be called by any two board members, with 24 hours notice.

on the same day and at the same time each month, to be determined by the board. Special meetings may be called by any two board members, with 24 hours notice.

Replace with: The regular meeting of the organization shall be held quarterly determined by the executive board. Special meetings may be called by any two board members, with 24 hours notice.
